Torbiera di transizione situata in una conca nella pecceta sul versante nord della catena porfirica del Lagorai a sud di Predazzo. Sono presenti habitat di particolare interesse non compresi nell'all.I della direttiva 92/43/CEE, in particolare: Caricetalia fuscae (5%).

4.2 Quality and importance

La presenza di alcune rare specie palustri, l'eccellente stato di conservazione uniti all'ambiente decisamente poco antropizzato (difficoltà di accesso), rendono il sito decisamente apprezzabile dal punto di vista botanico. Si tratta di un biotopo di vitale importanza per la riproduzione di molte specie di anfibi e rettili.
