Antico laghetto in fase di interrimento, circondato da faggeta con peccio. Il sito comprende anche un vicino prato umido con moliniato e vari cariceti. Sono presenti habitat di particolare interesse non compresi nell'all.I della direttiva 92/43/CEE: Magnocaricion (5%).

4.2 Quality and importance

Alcuni aspetti floristici (rare specie di salici) e vegetazionali (soprattutto alcuni cariceti poco diffusi) sono degni di nota e giustificano la segnalazione del sito. Si tratta di un biotopo di vitale importanza per la riproduzione di molte specie di anfibi e rettili.
