Other Site Characteristics

Caratteristiche balze basaltiche aride in area a clima continentale, soggette fin da tempi assai antichi alla pastorizia da parte degli abitanti dei villaggi siti nei pressi. Oltre alle aree erbose steppiche, sono diffuse crittogame termofile (muschi e licheni) e siepi di arbusti spinosi. Habitat 6210 prioritario (stupenda fioritura di orchidee) con copertura del 17% del Sito.

4.2 Quality and importance

Buon esempio di vegetazione erbosa steppica continentale a *Stipa capillata*, con altre rarità floristiche. Il sito è inoltre di rilevante importanza per la nidificazione, la sosta e/o lo svernamento di specie di uccelli protette o in forte regresso, e/o a distribuzione localizzata sulle Alpi.
