4.2 Quality and importance

Cavità costituita da una serie di ampie gallerie, con ingresso a 467 m slm, nella formazione della Dolomia Principale, lungo un ripido versante con copertura vegetale discontinua di faggi, querce, pini silvestri. Morfologia ed idrologia complesse, con una serie di laghetti (oltre 30) e sifoni, sia stagionali che perenni, con presenza di sorgenti. Esistenza di concrezioni macrocristalline.
