La grotta si apre a m 610 slm., nella formazione di Calcarei Grigi. E' costituita da un'unica galleria discendente. L'idrologia ed il regime termo-igrometrico della grotta sono determinati da un sifone oscillante nella parte terminale. Le concrezioni di maggiori dimensioni sono fossili, ma è presente un concrezionamento attivo.
