Da segnalare, per il valore intrinseco di questa zona, l'importanza della componente muscinale, con specie non ancora completamente e dettagliatamente monitorate, oltre a due specie rare per la Provincia di Trento, Alchemilla longana e Paludella squarrosa, la prima una Rosacea dei pascoli umidi alpestri e la seconda una specie muscinale di torbiera ed ambienti umidi affini. Tutte si collocano nelle aree torbose della fascia basale

4.2 Quality and importance

Il sito è caratterizzato dalla presenza di alcune stazioni, accertate da ripetute segnalazioni convalidate, di Botrychium simplex Hitchc., una Pteridophyta inclusa nell'All.2 della Direttiva 43/92 CEE, vegetante nell'ambito di formazioni torbose largamente riferibili all'habitat 7140 (torbiere di transizione e instabili).
